2023 GRANDMA'S[®] COOKIES FOR A YEAR USG SWEEPSTAKES ("SWEEPSTAKES") OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. 1.
